PRACTITIONER WEBSITE OPTIONS TAX YEAR 2011

Option 1: OLF Link Only...Annual fee - Free

We provide the HTML code which enables you to run the ProTaxNet Online Filing Launch Page in a frame on your existing website. Note: You must have your own website to use this option.

HTML code is emailed to you in a text file upon registration. Simply copy the text and paste it into the <BODY> section of your HTML page.

There is no cost for this one-year option. Active from Dec 15, 2011 to Dec 15, 2012

Revenue Sharing is not included, but is available as an add-on option for \$29.00 (see below)

Option 2: Full ProTaxNet Website...Annual fee - \$50.00

We provide the hyperlink (URL) to your ProTaxNet website, complete with the following features:

- Your company info link displayed on Home Page
- Info pages for Online Filing, Professional Tax Services, ProTaxNet support
- Tax Central content with tax topics, organizers, calculators, and more
- Online Filing program access, usage statistics available at www.protaxnet.com

Your unique ProTaxNet hyperlink (URL) is emailed to you upon registration. Use the hyperlink on print media such as business cards and brochures, or forward the hyperlink to online filing prospects via email.

The cost for this one-year option is \$50.00. Active from Dec 15, 2011 to Dec 15, 2012

Revenue Sharing is not included, but is available as an add-on option for \$29.00 (see below)

Add Revenue Sharing to Option 1 or Option 2...Annual fee - \$29.00

At a \$5.00 per paid Federal return Revenue Share, you would need to generate 6 paid Federal tax returns to recover your \$29.00 Revenue Sharing cost. In 2011 75% of ProTaxNet Online Filing customers who completed their return paid for their Federal return, while the remaining 25% completed the free Basic, so you may need 8 or 9 Online Filing customers to complete their returns (2 or 3 for free) for Revenue Sharing to pay for itself.

The cost for this one-year option is \$29.00. Active from Dec 15, 2011 to Dec 15, 2012
